Day/Time

- **POS US/Canada – Australia**
For mid-week fares: permitted MON/TUE/WED/SUN on each trans-Pacific sector.
For Weekend fares: permitted THU/FRI/SAT on each trans-Pacific sector.
- **POS US – New Zealand**
For mid-week fares: permitted MON/TUE/WED/THU on each trans-Pacific sector.
For Weekend fares: permitted FRI/SAT/SUN on each trans-Pacific sector.

Seasonality

- **POS US – Australia**
For **O-type** and **T-type** fares:
Low: permitted 22 November – 5 December 2023 or 15 January – 28 June 2024 or 24 July – 11 November 2024.
Shoulder: permitted 8-14 January 2024, 29 June – 23 July 2024 or 6-12 December 2024.
For **I-type** fares:
Seasonality does not apply.
- **POS US – New Zealand**
For **O-type** and **T-type** fares:
Low: permitted 30 January - 5 July 2024 or 24 July - 4 December 2024.
Shoulder: permitted 14-29 January 2024, 6-23 July 2024 or 5-12 December 2024.
For **I-type** fares:
Low: permitted 1 February - 10 December 2024.
High: permitted 11 December 2023 – 31 January 2024.
- **POS Canada – Australia**
For **O-type** and **T-type** fares:
Low: permitted 1 May - 8 June 2024 or 24 July - 25 October 2024.
Shoulder: permitted 1 February - 30 April 2024, 9 June - 23 July 2024 or 26 October - 10 December 2024.
For **I-type** fares:
Seasonality does not apply.

Flight Application

- Valid on Qantas operated flights only.

Advance Reservation/Ticketing

- For **-03UQ/-04UQ** type fares: Reservations for all sectors required 31-60 days before departure.
- For **-01UQ/-02UQ** type fares: Reservations for all sectors are not permitted until 30 days prior to departure.

Minimum Stay

- 12 hours

Maximum Stay

- No later than 12 months after departure from fare origin

Blackout Dates

- 13 December 2023 – 2 January 2024 for Economy and Premium Economy travel

Travel Restrictions

- Fares permitted for travel on/before 31 December 2024 during low/shoulder season

Sale Restrictions

- Fares permitted for sale on/before 31 March

Changes

- **POS US – Australia/New Zealand**
For **O-type** and **T-type** fares:
Charge **US\$500** for reissue/revalidation. Fare **forfeited** in the event of **no-show**.
For **I-type** fares:
Charge **US\$300** for reissue/revalidation. Fare **forfeited** in the event of **no-show**.
- **POS Canada – Australia**
For **O-type** and **T-type** fares:
Charge **C\$500** for reissue/revalidation. Fare **forfeited** in the event of **no-show**.
For **I-type** fares:
Charge **C\$300** for reissue/revalidation. Fare **forfeited** in the event of **no-show**.
